This report documents the selection of collective agreements in the Eurofound database of collective agreements for low-paid workers. The database includes a sample of collective agreements for each of the selected low-paid sectors of interest. The documentation summarises how the task of identifying relevant agreements was approached, if and to what extent full registers of collective agreements with the required meta-data were available or, in their absence, which other approaches had to be taken. In addition, the documentation includes background information on the relevant member state's sectoral collective bargaining, its actors and functioning, and a description of the sampling approach, as well as basic information on the collective agreements proposed to be included in the database for each of the ten low paid sectors of interest.

Detailed information related to each collective agreement can be found online in the visual dashboard with a live connection to the database.

General information

National collective bargaining agreements) were identified and listed thanks to the public openaccess archive of the Italian Council for Economics and Labour (CNEL), a detailed and exhaustive register providing the text of each renewal and information about the NACE-2 sector of every sectoral collective agreement in Italy. This archive also provides basic information regarding signatory parties, period of validity date. As for coverage, it is generally available by cross-referencing data from the Ministry of Labour and from the National Social Security Institute (INPS/UNIEMENS system) which is collected by means of compulsory declarations by companies. Coverage is not available for only two sectors – agriculture and domestic work – as companies in these two sectors are not subject to the general compulsory declaration on applies collective bargaining.

As the sectoral level is the main level of bargaining in Italy, the CNEL register proved to be a valuable instrument for the purposes of this research project. Despite being a complete register, in most cases it provides the official texts of the renewal of collective agreements, meaning that only the articles that changed as a result of the social partners' negotiation are included in the available texts. The complete, integrated text of each agreement, however, is often nor provided. This makes it difficult to have a complete overview of the full agreement and its evolution over time, but it is not – apart from some exceptions – an issue for the purposes of this specific research project, mainly focused on basic minimum wages.

Company-level bargaining also exists, but it normally only integrates sectoral bargaining, and collectively agreed minimum wages are primarily provided for by sectoral collective bargaining.

National-level cross-sectoral agreements are often wide framework agreements establishing the rules of collective bargaining, and do not include minimum wages. They are therefore not withing the scope of this research project.

1 - Agriculture

Background information

The main actors of collective bargaining in the agricultural sector in Italy are, on the trade union side:

- CGIL (Italian General Confederation of Labour), which operates in the sector through its member FLAI-CGIL (Federation of Agro-Industry Workers).
- CISL (Italian Confederation of Workers' Unions), which operates in the sector through its member FAI-CISL (Italian Agricultural, Food, Environmental and Industrial Federation).
- UIL (Italian Labor Union), which operates in the sector through its member UILA-UIL (Italian Union of Agri-food Works).

On the employers' organisations side, we can mention:

- Confagricoltura.
- Coldiretti.
- CIA (Confederazione Italiana Agricoltori).
- Confcooperative (Confederation of Italian Cooperatives), which operates in the sector through its member Federagripesca (Federation of Agriculture and Fisheries) and through its section 'Work and Services'.
- Legacoop (National League of Cooperatives and Mutuals), which operates in the sector through its section Legacoop Agroalimentare (National Association of Agro-forestry Cooperatives for Rural and Coastal Development).
- AGCI (General Association of Italian Cooperatives), which operates in the sector through its section AGRITAL (Agri-fishing-food section).
- ASSOCAP (National Association of Agricultural Consortia).
- AIA (Italian Livestock Breeders Association).

Existing bargaining levels are: national level, provincial level, and company level.

National level agreements set minimum economic and regulatory rights, which collective agreements at other levels may modify or specify depending on the context in which they are negotiated.

National collective agreements in force in the agricultural sector are 58 (source: XXIV CNEL Report December 2022).

While in the majority of sectors employers have the obligation to declare the national collective agreement applying to each of their workers through a system called UNIEMENS run by INPS (National Institute for Social Security), agricultural employers are not bound by such obligation: as a result, figures of collective bargaining coverage in this sector are unavailable, and even rough estimates result impossible.

Sampling information

Sector related coverage figures of workers for each national collective agreement are not available in the agricultural sector, as explained in the Background section. However, the largest agreements have been identified due to the predominant role of the social partners who negotiated/concluded/signed them. These social partners are comparatively more representative at national level.

Additionally, the listed agreements, apart from being signed by the most representative actors, are also those which have existed for longer time, shaping the system of industrial relations in the sector.

Despite the impossibility of reliably assessing the coverage of collective agreements in agriculture, it can be assumed, given the methodology we have implemented in selecting the nine listed agreements (see above), that:

- No major collective agreement is missing from the sample.
- The nine listed agreements provide, together, a very large coverage of NACE-2 workers potentially covered by collective bargaining. The coverage is estimated between 50 and 89% (in the Listed agreement tab), and there are reasons to believe that the precise percentage is extremely likely to be in the highest end of this range.

In the first stage correspondents were asked to list sector related collective agreements with basic information. In some cases, only a selection of the listed agreements was then 'fully coded' and included in the database.

In case of 1 - Agriculture 9 collective agreements were listed, and out of these 9 were approved for coding and fully included in the database.

Self-assessed proportion of included agreements

Based on all available figures, and to their best knowledge, the author assesses that the listed collective agreements are likely to cover:

- A good selection of the most important agreements related to 1 Agriculture (as defined in the project)
- Most (more than 50% to 89%) of those workers in 1 Agriculture (as defined in the project),
 which are covered by a collective agreement.

2 - Manufacture of food, leather, textiles, and clothes

Background information

The main actors of collective bargaining in the manufacturing sector in Italy are, on the trade union side, the Italian General Confederation of Labour (CGIL), the Italian Confederation of Trade Unions (CISL), and The Italian Labour Union (UIL). Depending on the production sub-sector, different federations of the above-mentioned confederations come into play.

Given the very high number of sub-sectors in the manufacturing industries, we focus on the NACE-2 sectors of interest for the purposes of the database in highlighting the main actors:

In manufacture of food and beverage products, the following trade unions represent the main actors:

- CGIL (Italian General Confederation of Labour), which operates in the sector through its member FLAI-CGIL (Federation of Agro-Industry Workers).
- CISL (Italian Confederation of Workers' Unions), which operates in the sector through its member FAI-CISL (Italian Agricultural, Food, Environmental and Industrial Federation).
- UIL (Italian Labor Union) which operates in the sector through its member UILA-UIL (Italian Union of Agri-Food Works).

In the textile, leather products and wearing apparel sectors the following trade unions represent the main actors:

- CGIL (Italian General Confederation of Labour), which operates in the sector through its member FILCTEM-CGIL (Italian Federation of Chemical Textile Energy Manufacturing Workers).
- CISL (Italian Confederation of Workers' Unions), which operates in the sector through its member FEMCA-CISL (Federation of Energy, Fashion, Chemistry and related activities).
- UIL (Italian Labor Union), which operates in the sector through its member UILTEC-UIL (Italian Union of Textile, Energy and Chemical Workers).
- UGL (General Labour Union), chemicals and textiles section.

As for employers' organisations, we can mention, for all NACE-2 sectors of interest in Manufacturing:

• Confindustria (General confederation of italian industry), operating in the food and beverage sector through several associations of employers: Federalimentare (Italian Federation of the Food Industry), ANCIT (National Association of Fish Canneries), ANICAV (National Association of Vegetable Canned Food Industries), ASSALZOO (National Association of Zootechnical Feed Producers), ASSICA (Industrial Association of Meats and Cured Meats), ASSITOL (Italian Association of the Oil Industry), ASSOBIBE (Italian Association of Non-Alcoholic Beverage Manufacturers), ASSOBIRRA (Association of Brewers and Malters), ASSOCARNI (National Association of Meat and Livestock Industry and Commerce), ASSOLATTE (Italian Dairy Association), ASSOVINI (Italian Federation of Industrial Producers, Exporters and Importers of Wines, Spirits, Liqueurs, Syrups, Vinegars and Similar Products), ITALMOPA (Industrial

Association of Millers of Italy), MINERACQUA (Italian Federation of Natural Mineral Water and Spring Water Industries), and UNIONE ITALIANA FOOD (ITALIAN FOOD UNION); and in the textile sector through its federation 'Confindustria Moda', operating though sectoral associations such as Assocalzaturifici (National association of Italian shoe manufacturers), AIP (Italian fur coating association), Assopellettieri (Italian leather goods association), SMI (Italian Fashion System), and UNIC (National union of the tanning industry).

- Confapi (Italian confederation of small and medium private industry), operating in the food sector through the sectoral association Unionalimentari (National union of small and medium-sized food industries) and in the textile sector through the sectoral association Uniontessile (National union of small and medium-sized textile-clothing industries).
- Confartigianato.
- Casartigiani (Autonomous Confederation of Craftsmen's Unions).
- CNA (Italian Confederation of Craft Trades and Small- and Medium-Sized Enterprises), which operates in the food industry sector through several member federations.
- CLAAI (Confederation of Free Italian Craft Associations).
- Confcooperative (Confederation of Italian Cooperatives), which operates in the sector through its member Federagripesca (Federation of Agriculture and Fisheries).
- Legacoop (National League of Cooperatives and Mutuals), which operates in the sector through its section Legacoop Agroalimentare (National Association of Agro-forestry Cooperatives for Rural and Coastal Development).
- AGCI (General Association of Italian Cooperatives), which operates in the sector through its section AGRITAL (Agri-fishing-food section).

Existing bargaining levels are: national, territorial, and company-level.

National level agreements set minimum economic and regulatory rights, which collective agreements at other levels may modify or specify depending on the context in which they are negotiated.

Regarding collective agreements in force in the manufacturing sector and the sectoral collective bargaining coverage, data are not precise due to the fact that there is a partial overlap with other economic sectors. Therefore, an approximate estimate of the figures is offered: there are around 200 national collective agreements in the manufacturing sector.

Sampling information

Thanks to the National Institute for Social Security (INPS) and the UNIEMENS data collection (which entails the obligation to all employers to declare the national collective agreement applies to each of their employees), sector related coverage figures of workers for each national collective agreement are available in the manufacturing sector.

The collective agreements included into the sample are the ones negotiated/signed by the comparatively more representative social partners at national level and with higher coverage figures. In this sector, collective agreements with these characteristics are numerous, and the most important ones in terms coverage have been listed and coded.

Despite the relatively low number of listed collective agreements (ten out of the over 200 existing in the whole NACE-1 manufacturing sector), administrative data confirms that the listed agreements cover, together, the large majority of employees in the NACE-2 sectors of interest (C-10, C-13, C-14 and C-15) covered by collective bargaining.

No major agreement is missing from the sample and overlaps of covered employees within the sector is not an issue since no company-level agreements have been listed.

Self-assessed proportion of included agreements

Based on all available figures, and to their best knowledge, the author assesses that the listed collective agreements are likely to cover:

- A good selection of the most important agreements related to 2 Manufacture of food, leather, textiles, and clothes (as defined in the project)
- Nearly all (90% to 100%) of those workers in 2 Manufacture of food, leather, textiles, and clothes (as defined in the project), which are covered by a collective agreement.

3 - Construction excl. civil engineering

Background information

Main actors of collective bargaining in the construction sector in Italy are, on the trade union side:

- CGIL (Italian General Confederation of Labor), which operates in the sector through its member FILLEA-CGIL (Italian Federation of Workers in Wood, Construction, Related and Extractive Industries).
- CISL (Italian Confederation of Workers' Unions) which operates in the sector through its member FILCA-CISL (Italian Federation of Construction and Related Workers).
- UIL (Italian Labour Union), which operates in the sector through its member FENEAL-UIL (Italian Federation of Related Construction and Wood Workers).

On the employers' organisations side the following actors should be mentioned:

- Confindustria (General Confederation of Italian Industry), which operates in the sector through its member ANCE (National Association of Builders).
- Confapi (Italian confederation of small and medium-sized private industry), which operates in the sector through its member ANIEM (National union of manufacturing construction companies and related sectors).
- CNA Construzioni (National Confederation of Crafts Construction).
- Confartigianato (Italian General Confederation of Crafts Construction), which operates in the sector through its member ANAEPA (National Association of Construction Craftsmen of Decorators, Painters and Related Activities).
- Casartigiani (Autonomous Confederation of Craftsmen's Unions), which operates in the sector through its member FIAE (Italian Federation of Building Craftsmen).
- CLAAI Edilizia (Free Confederation of Italian Artisan Associations Construction).
- AGCI Produzione e Lavoro (General Association of Italian Cooperatives Production and Work).
- Legacoop Produzione e Servizi (National League of Cooperatives and Mutuals Production and Services).
- Confcooperative Lavoro e Servizi (Confederation of Italian Cooperatives Work and Services).

All above-mentioned actors (both trade unions and employers' organisations) are members of CNCE (Commissione Nazionale Paritetica per le Casse Edili - National Joint Committee for Building Funds), the national-level bilateral body composed of the social partners who have signed the most representative national collective agreements for the construction industry in terms of workers coverage. Its mission is that of addressing, controlling, and coordinating the system of the around 120 'casse edili' existent on the Italian territory, which are exclusive organizations in the construction sector, which arose in relation to the peculiarity of employment relationships, characterized by a significant inter-company mobility of workers. The function of the 'casse edili' is that of ensuring the welfare-related institutes provided by law and by collective agreements to construction workers.

Existing bargaining levels are: national, regional, provincial, company-level.

National level agreements set minimum economic and regulatory rights, which collective agreements at other levels may modify or specify depending on the context in which they are negotiated.

Thanks to the National Institute for Social Security (INPS) and the UNIEMENS data collection (which entails the obligation to all employers to declare the national collective agreement applies to each of their employees), sector related coverage figures of workers for each national collective agreement are available for the administrative and support service activities, although it is complex to identify precisely the collective agreements relating to this sector, given its fragmentation.

The collective agreements to be included into the sample are the ones negotiated/signed by the comparatively more representative trade unions at national level and with higher coverage figures according to administrative (UNIEMENS) data.

Considered that this section includes a variety of activities that support general business operations, agreements are numerous, and a sample of these have been codified in the dedicated section.

Despite the difficulties in identifying the applicable collective agreements and the boundaries of the activities in the NACE-2 sectors of interest of this NACE-1 sector, we believe - on the basis of administrative data (UNIEMENS) - that thanks to the methodology adopted in selecting the seven listed agreements most employees (over 50%) of those working in the NACE-2 sectors of interest and covered by collective bargaining have been captured by the sample.

Additionally, sectoral collective bargaining coverage is difficult to measure because workers in this sector in Italy are recorded and accounted for together with other workers in the macro-sector of 'Education, Health, Culture, Entities' (private sector).

For this reason, actors are not deemed to be 'main actors' and have not been explicitly listed in this section.

Collective bargaining is carried out at national level.

National collective agreements in force in the domestic work sector are between 25 and 30 (source: XXIV CNEL Report December 2022).

While in the majority of sectors employers have the obligation to declare the national collective agreement applies to each of their workers thorugh a system called UNIEMENS run by INPS (National Institute for Social Security), domestic employers are not bound by such obligation: as a result, figures of collective bargaining coverage in this sector are unavailable.

However, data can be drawn from the 2022 'Annual report on domestic work' published by the DOMINA Observatory.

The domestic work sector is one of the most problematic in Italy as far as data collection is concerned, because it is very much plagued by undeclared work. According to the DOMINA Observatory, the collective agreement on domestic work signed by DOMINA involves almost

900,000 regular workers to which, according to DOMINA estimates, based on ISTAT data, more than one million irregular workers should be added.

Sampling information

Sector related coverage figures of workers for each agreement are not available in the domestic work sector, for the reasons highlighted in the Background section (absence of administrative data).

However, what is deemed to be the largest agreement has been identified on the basis the predominant role of the social partners who negotiated/concluded/signed it (Domina/Fidaldo agreement). These social partners are deemed to be comparatively more representative at national level.

Moreover, two further agreements (identified by sticking to the methodology based on how long an agreement has been in force), have been listed and coded to ensure completeness in a sector with non-accessible and certain data.

No major collective agreements are missing from the sample: despite the existence of many collective agreements in the sector (see Background section), it is safe to assume that the three coded - and the Domina/Fidaldo one in particular - cover the large majority of the (regularly employed) domestic workers.

The estimation of coverage of the listed agreements, however, is not available for the lack of administrative data highlighted in the Background section.

12- Multi-sectoral agreements

Background information

Main actors of collective bargaining in the sector in Italy are, on the trade union side, CGIL, CISL, and UIL. On the employers' organisations side, it is difficult to identify reference actors given the heterogeneity of the sector.

Existing bargaining level is mainly the national one.

An estimation of the number of sectoral collective agreements and collective bargaining coverage is not possible at this stage, because of the fragmentation and heterogeneity of the sector and the difficulty of identifying its boundaries. Taking into account the classification adopted in Italy by the CNEL, some or all national collective agreements categorised in the macro-sectors "service companies" and "plurisectorial, microsectorial and other contracts" could be included in this section.

Sampling information

Thanks to the National Institute for Social Security (INPS) and the UNIEMENS data collection (which entails the obligation to all employers to declare the national collective agreement applies to each of their employees), coverage figures of workers for each national collective agreement are available for multi sectoral agreements, although it is complex to identify precisely the agreements related to this sector, given its fragmentation.

Considered that this section includes a variety of activities that do not belong to a single industry, related Italian national collective agreements are numerous and diverse, and it has not yet been possible to provide a meaningful sample.

Two collective agreements have been identified as covering more than one NACE-2 sectors of interest in different NACE-1 sectors.

The first (multiservice agreement) covers, as the name suggests, several auxiliary/integrative service activities and maintenance, ordinary and extraordinary, performed on a non-exclusive basis at the request of public and private clients. The progressive expansion of global service contracts, based on results and also including design and production management activities of the various services, facility management and integrated or multiservice, has in fact come to cover a plurality of service activities.

The second, despite the title (Bakery) covers not only production of baked products, but also complementary activities, as well as by retail shops selling bread, food, and various products.
